## 2. COMPOSITION / INFORMATION ON INGREDIENTS

**Hazardous ingredients:** CALCIUM CHLORIDE DIHYDRATE BP >90%

**Main hazards:** Irritating to eyes.

**Inhalation:** Remove casualty from exposure ensuring one's own safety whilst doing so. Consult a doctor.

**5. FIRE-FIGHTING MEASURES**
