**2. COMPOSITION / INFORMATION ON INGREDIENTS**

**Hazardous ingredients:** ETHYLENE GLYCOL >90%

**3. HAZARDS IDENTIFICATION**

**Main hazards:** Harmful if swallowed.

**4. FIRST AID MEASURES (SYMPTOMS)**

**Skin contact:** There may be mild irritation at the site of contact.

**Eye contact:** There may be irritation and redness.
